



2024 FEE INFORMATION

This document contains important information regarding Shepparton Christian College's 2024 Fee Schedule.

Fee Statements

Annual Fees are generated at the beginning of each year, and Fee Statements are created at the beginning of each term. Statements, Overall Balance and Recent Payments can be viewed at any time on the SEQTA Engage | Finance page.

Regular Payments Required

It is college policy that all fees be paid on a regular payment schedule. This can be weekly, fortnightly, monthly or term by term. **It is a requirement that 25% of fees be paid by the end of Term 1, 50% by the end of Term 2, 75% by the end of Term 3, and 100% by 31st December.**

Discounts

- Early Payment Discount

A discount of 5% off the net Annual Tuition Fee is offered if your account is paid in full by the end of February.

- Sibling Discount

A sibling discount of 25% off the Annual Tuition Fee for a 2nd child, 50% for a 3rd child, and 100% for a 4th and subsequent children is provided for families.

- Pastor/Staff Discount

Fee discounts are available for staff and pastors.

Fee Assistance/Concessions

- Health Care Card

A discount of 25% off net Tuition Fees will be applied for Health Care Card Holders upon the successful submission of a CSEF application (see below).

- Camp, Sport and Excursions Fund (CSEF)

CSEF is provided by the Victorian Government to assist eligible families to cover the costs of school trips, camps and sporting activities. Families who hold a valid means-tested concession card or are a temporary foster parent or students on Youth Allowance with their own HCC are eligible to apply for CSEF. Annual amounts are approx. \$150 for a primary student and \$250 for a secondary student. The allowance is paid to the school and will automatically be allocated against the student's outstanding camp/excursion levy. Any remaining funds will be allocated as directed by parents or roll over to the following school year.

Application forms are available at the college office. Please note that you do not need to fill in a new application each year, they will automatically roll over. If you have a new child in your family start at the school a new application will need to be filled in. Fee Assistance/Concessions cont.

- **Financial Hardship**

Concessions are available for families with demonstrated financial hardship. Please complete a confidential "Financial Hardship" form, available at the college office, for concession consideration. Please note a new application must be submitted each year. If you require further information, please speak with the Principal or Business Manager.

The College requires four week's notice of withdrawal or payment of four weeks fees in lieu of notice.

ADDITIONAL FEES AND LEVIES

Camp/Excursion Levy

The Camp/Excursion levy is a compulsory levy. A different levy is applicable for each year level. The levy covers all camps (Grade 4 - Year 12), all excursions (Prep to Year 12), secondary extra-curricular program, primary swimming program and sporting events held throughout the year. The levy is payable regardless of a student's ability to attend excursion/camps throughout the year. Please note Outdoor Education camps are not included in this levy.

Building Fee Levy

The Building Fee Levy is a compulsory charge to contribute towards the provision and maintenance of buildings. It is not tax deductible and is non-refundable.

Vocational Education and Training (VET) Subjects

VET subject levies vary depending on the provider. Students who have chosen VET subjects through another education provider (e.g. TAFE), will be informed of the cost. Charges generally vary between \$2000-\$3500. The board has agreed to subsidise half the cost of each course. The college will pay the full cost directly to the VET provider. 50% will then be charged to each student's college fee statement.

Distance Education Subjects

Students who have chosen to complete a VCE subject by distance education will be informed of the cost. Subjects through Distance Education Centre Victoria are approx. \$850 per year. The college Board has agreed to cover half this cost. The college will pay the full cost directly to the DE provider. 50% will then be charged to each student's college fee statement.

Outdoor Education Subject Levies

Students who choose Outdoor Education as an elective will incur an annual levy to cover additional costs associated with the subject ie camps, equipment, etc. Please be aware that this levy is compulsory regardless of a student's ability to attend any camps/excursions. All trips are compulsory unless a medical certificate is provided. The Outdoor Education Levy is separate and additional to the Camp/Excursion levy.

Outdoor Education involves physically and mentally challenging activities which are outdoor and adventure based. These activities may include abseiling, white water rafting, snow skiing, hiking or canoeing.

Music Tuition

Music Tuition is available through the college for a variety of instruments. Expression of Interest forms are available at the office (waiting lists may apply). Lessons are weekly for a duration of 30 minutes. Please note that students will be allocated individual or group lessons at the discretion of the music co-ordinator. Music Tuition fees are generated at the beginning of each term (\$30 per lesson per week). The fee is added to your fee account but must be paid by the end of each term. If lessons are not paid for by the end of the term, students may not be able to continue lessons the following term. If a student chooses to withdraw from lessons, 4 weeks' notice must be given.

This is an extra-curricular activity and no subsidies/financial assistance applies.

Bus Travel

Local Town Bus Travellers (Conveyance Allowance Program)

Students who live in the townships of Shepparton, Mooroopna or Kialla and live more than 4.8kms from the college are eligible for free bus travel. This service is provided through the local town bus system (Dysons and Jacobsons). **Student Conveyance Allowance applications are available at the office and need to be returned to the college by the end of the first week of December.** Students that travelled by bus in one year do not need to apply again for the following year. It is assumed travel will continue unless the college is notified otherwise. *If you do not meet the above criteria, conveyance cards can be purchased directly from Dysons (Shepp/Kialla travellers) or Jacobsons (Mooroopna travellers) for approximately \$130 per term per student.*

Country Bus Travellers (School Bus Program)

A country bus service is available from most outlying towns. **Country Bus Applications are available from the office and need to be returned to the college by the end of the first week of December.**

Eligibility requirements for Country Bus Travellers:

To be eligible for travel on a country school bus at no cost, non-government school students must attend their closest "appropriate" school, which is determined by the denomination of the school. For SCC students, this will mean that if you are Prep-Grade 6 student and live closer to Benalla Christian College or a Prep-Year 10 student and live closer to River City Christian College Echuca, you will not be eligible for free bus travel. Government and Non-Government students not attending their closest school will be required to pay a fare each term as set by PTV (Public Transport Victoria). Approximate cost is \$120 per term, per student. You will be notified of ineligibility and the associated costs involved via letter, upon submission of your bus travel form.

Student Laptops

Laptops must be purchased through the college portal and are compulsory for all secondary students. Having a limited number of types of systems means our technician is familiar with the laptops, the drivers and maintenance of these systems. When problems occur, we are able to be the first level of support. If a problem is unable to be resolved internally, all laptops come with a three-year onsite warranty and we have found that most issues are resolved in a matter of days.

Our licencing agreement means that we are only allowed to install school licenced software on systems that are "managed" by the college. Having a limited number of options allows us to "manage" student/parent owned laptops and install extensive software.

Laptops not purchased through the college portal will not be accepted in the college environment.
